Distribution of awards

No quota allocation of studentships to institutions or to subject areas

Types of award

- Full-time
- Part-time
- Full (fees and stipend) studentships

Eligibility

Awards for **UK residents** cover UK tuition fees and provide a stipend at the UK Research and Innovation (UKRI) rate

International students will also be able to apply for an AHRC funded postgraduate studentship for the start of the 2024 academic year. They will be eligible for tuition fees at the UK rate and a stipend to support living costs. UKRI (AHRC) funding will not cover international fees set by universities or the costs associated with obtaining a visa. Please see the UKRI website for further details. EU applicants are now classified as international students.

Awards

Indicative rate for the 2023/2024 academic year

Full-time Fees £4,712 Maintenance grant £18,622

Part-time Fees £2,356 Maintenance grant £9,311

Additional funding to support research activity is available to apply for during the PhD.

Duration of Awards

Open competition award - **3.5 years baseline funding** (but a case can be made to extend this for up to 6 months at the point of application or at the mid-year review in the first year, subject to the requirements of the project). Submission within 4 years.

Collaborative Doctoral Award – **4 years** (funding and

submission)







Additional Funding

Research Development Fund (RDF)

The RDF is designed to support primary research activities for individual students, including:

- Participation in conferences
- Primary research/archive/fieldwork visits
- Study visits in the UK and overseas

Engagement Fund (EF)

The EF will allow students who are undertaking placements and other activities that are engaged with professional development to access additional funds to support them. The Engagement Fund will cover accommodation, travel and other associated costs, including specialist training.

Cohort Development Fund (CDF)

- Devised and led by a minimum of two doctoral researchers from two or more M4C institutions
- Conference, workshop, symposia, retreats, skills training
- Research networking training and development activities
- · Discipline-crossing research
- Researcher-led responses to external partner challenge themes
- Innovative training for language researchers





Application process for 2024 entry

Application deadline: 10 January 2024 at noon GMT

(All guidance and link to the online application portal live on M4C website on 16 October 2023)

Stage one:

Choose between Open Doctoral Competition and CDA

- Open competition: identify potential supervisors
- CDA: select project and contact lead supervisor

Under M4C rules, a candidate can submit applications to both the Open and CDA competitions


Application process for 2024 entry

After choosing the Open Competiton or a CDA project -

Stage two

- Apply for a place at your chosen M4C institution Consult 'home' university PhD application pages
- Find two academic references
 - The M4C online reference form **MUST** be used You need to nominate and provide details of two referees via the M4C online application portal so that they can be contacted to provide your reference. Your referee will be sent an automated request to complete the M4C reference form









Application process for 2024 entry

Stage three

Apply for M4C funding

Submission via M4C online application portal

- Guidance notes for applicants and link to online application form are available on the website
- Supervisor search pages for each of the M4C universities
- You will need your Applicant ID number to be provided by home institution
- Shortlisted applicants will also have an interview at their home institution.

Successful applicants notified by the end of April 2024.





M4C/Stuart Hall Foundation Studentship

We are delighted to announce a new partnership between the Stuart Hall Foundation and Midlands4Cities Doctoral Training Partnership (M4C) to support one or two studentships a year for black, Asian and minority ethnic applicants to undertake doctoral research in arts and humanities.

As well as the usual benefits of an M4C studentship, successful applicants will benefit from working with SHF to develop their career and research profile. Post holders will be able to engage with and contribute to the resources and networks of the Stuart Hall Foundation, including an annual gathering of Stuart Hall Foundation Scholars and Fellows, and privileged access to the work of the Foundation.

Eligibility:

 Eligible applicants will be those classed as having 'home students' fee status and identify as belonging to a minoritized and under-represented ethnic groups.

To apply:

- Indicate your wish to be considered for an M4C/SHF Studentship.
- This will bring up an open text box, in which you should outline why you wish to be considered and what you would offer.
- Your application for an M4C/SHF studentship will be considered at a later point in the recruitment process, by the Stuart Hall Foundation as well as by M4C processes.

M4C Assessment Criteria: a fuller account is available on the M4C website PROJECT

• Is the project focused? Is the student proposing to use an appropriate research methodology? Does the student demonstrate that they know the field? Is a case made for the project's cutting edge qualities in relation to existing scholarship?

PERSON

• Quality of student (evidence might include a First Class degree and excellent MA-level marks; or a good first degree and professional or other experience relevant to the project; or a combination of these models). Does the applicant have the right skills and knowledge to undertake the project?

PREPAREDNESS

• Is the student prepared for the proposed programme of study? Do they have relevant UG and/or MA degrees? Do they have relevant language and/or IT skills? Are they familiar with, for example, the need to undertake archival work, if appropriate?

PLACE

- Does the project have a good 'fit' with the department or School, or to particular research Centres or Institutes? Are there particular staff members with expertise in the proposed area, and who would make an ideal supervisory team?
- Fit to M4C? Opportunities for cross-HEI supervision? Relationships with partners?





<u>Tips to ensure your referees submit their references on time:</u>

- 1. Read and follow the guidance notes before submitting your reference request.
- 2. Check that your referee has received the reference request. It may have been delivered to their spam/junk.
- 3. Complete the M4C reference request section of the application form as early as possible but no later than 1st December. Do not leave it until the Christmas break when many colleagues are unavailable.
- 4. In most cases, your referee is only required to complete the M4C reference form. These will be used by the Admissions Office at your home university and in support of your M4C funding application.
- 5. Referees should wait for the automated email requesting a reference and not sign up to the online platform as an applicant to submit a reference.
- 6. It is the applicant's responsibility to monitor the reference progress and check that everything has been receive
- 7. Double check that you have inputted the correct email address for your referee.
- 8. Applications cannot be submitted without 2 completed references.
