# Notes for contributors

## Submission of manuscripts

The Editors welcome submission of articles (6,000 to 8,000 words) and proposals for review articles (4,000 words) and for guest-edited monographic issues (6 to 7 articles). All materials are published in English, with quotations given in the original language followed by English translation. Authors should submit articles as attachments, formatted as Microsoft Word or Rich Text Format files, along with complete contact information, by e-mail to sara.charles@sas.ac.uk. Electronic submissions are preferred, but mailed contributions will be reviewed.

Please also supply an abstract for your article (100 to 150 words), 6 to 8 keywords, a biographical note (approximately 100 words), and contact information (including e-mail and mailing address) up to the planned date of publication. All text in the article should be doublespaced with 2.5 cm margins and numbered pages. Notes should be kept to a minimum and placed at the end of the text.

References should be indicated in the typescript by giving the author's name and year of publication in parenthesis, e.g. Resina (2000: 83–125) or (Resina 2000: 83–125), as appropriate. If several publications are cited by the same author from the same year, then a, b, c, etc. should be put after the year of publication. All references cited in the text should be listed in full at the end of the article, under the heading 'Works cited', as follows:

For books: Resina, Joan Ramon (ed.) (2000) Disremembering the Dictatorship: The Politics

of Memory in the Spanish Transition to Democracy (Amsterdam and Atlanta GA:

Rodopi).

**Photographic illustrations** should be submitted as separate TIFF files (resolution at 300 dpi) and approximately  $10 \times 8$  centimetres. Colour images are acceptable. Tables and corresponding captions should be placed in separate files; captions should also appear in the main text, along with placement indicators and sources. Authors are responsible for clearing permission to reproduce, including payment of any fee.
