

- Anxiety



# Decadence/Aestheticism

- "Art for Art's sake" Théophile Gautier
- Gaining sensuous pleasure from Art, rather than a moral or intellectual sentiment
- Life should imitate Art, not Art life
- Reaction against Victorian moralism, and didactic approaches to art
- John Ruskin [Art = Truth], Matthew Arnold

# Evolution, Scientific Progress and Degeneration

- Evolutionary theory questioned Man's place in nature; Natural Selection
  - Herbert Spencer, Thomas Henry Huxley, Ray Lankester
- Jean-Baptiste Lamarck (1744-1829): adaptation to environment, "use & disuse"
- Benedict Morel: Treatise on Degeneration (1857) - hereditary degeneracy
- Cesare Lombroso - atavistic retrogression, criminality

- Max Nordau: Degeneration (1892) - application to cultural criticism

*"The disposition of the times is curiously confused, a compound of feverish restlessness and blunted discouragement [...] the prevalent feeling is that of imminent perdition and extinction. Fin de siècle is at once a confession and a complaint [...] a Dusk of the Nations in which all suns and all stars are gradually waning, and mankind with all its institutions and creations is perishing in the midst of a dying world."*

# Urbanisation, Poverty, Insanity, Prostitution and Crime

- Mid-century immigration from Ireland, Eastern Europe and Russia
- Population growth, City expansion, Suburbs and Slums
- Sanitation, poor health
- Perceived increase in Crime
- Jack the Ripper murders of 1888

# New Technologies and Infrastructure

- Transport: Steam Ships, Railways, Bicycles
- Tropical Medicine
- Communication: Telegraph, Telephone, Typewriter
- Electric Lights
- Entertainment: Radio, Cinema, Photography



# "New Women"

- Married Women's Property Act (1882)
- 1878: University of London becomes first university to admit women to degree programmes
- 1878-1893: Oxford opens first women's colleges (Lady Margaret Hall, Sommerville, St Hugh's St Hilda's)
- 1869-1895: Cambridge opens Girton, Newnham, Hughes
- Women's Suffrage Movements

# Medico-legal theories of Sexuality

- Criminal Law Amendment Act (1885)
  - Raised age of consent from 13 to 16
  - Strengthened legislation against prostitution
  - Recriminalised male homosexuality
- Section 11 (Labouchere Amendment) two years imprisonment for "gross indecency" between men in "public or private"
- Oscar Wilde trials (1895)
