### **Year 1**

All modules taken in the first year will be FHEQ level 4 (Undergraduate Level 1). Students must register for 120 CATS in total. Overcutting and undercutting is not permitted in any circumstances.

Student must choose between two routes: **ROUTE 1 (Statistical Analysis)** and **ROUTE 2 (Quantitative Analysis)**.

### Economics Core Module

Students must take EC120-30. This module is comprised of either EC122 and EC139, or EC122 and EC140, or EC124 and EC139, or EC124 and EC140. Students must choose their preferred combination. The mark for EC120 will be an average of the two module marks in their chosen combination. This average will need to be at least 40 to pass the module, but this does not require both two module marks individually to be 40 or above.

**To progress to their second years students must pass all required core modules, which includes passing EC120 overall with a mark of at least 40, and achieve a year mark of at least 40%**

## **Second Year**

All modules taken in the second year must be FHEQ level 5 (Undergraduate Level 2).<sup>1</sup> Students must register for 120 CATS in total. Overcatting and undercatting is not permitted in any circumstances.

In the second year, students may opt to spend terms two and three studying abroad.
