

It is an MASc because we are interdisciplinary and transdisciplinary. This means we also offer students the opportunity to study across the range of Arts & Humanities and Social Sciences. We recognise this as an important part of our approach and this is reflected in the degree title. It goes beyond just a focus on the social sciences or the natural sciences.

I personally have really enjoyed my course so far as the modules I was able to take with PAIS tied really well into Global Sustainable Development. GSD in particular has been interesting as it's very interdisciplinary, so you're introduced to sustainability from environmental/ social and economic perspectives. At the moment I'm planning on doing a Masters in International Development :)



The Masters is very much focused on supporting students to develop their leadership skills and forms of practice in GSD. The core subjects in term 1 focus on providing introductions to the importance of leadership and developing your own rationale and ethos for what you want to do, as well as thinking about transdisciplinary skills. In term 2 you can take optional modules - including outside GSD in Arts and Humanities, or if you are eligible, in natural and life science modules, as well as focus on methods. YOu can also develop your understanding of work based practices. In the 3rd term, the capstone project can either be an academic dissertation or a research report or more focused policy directed output, or a work placement. We therefore hope to bring together lots of opportunities and challenges in a practical but also a rich methodological and philosophical and theoretical framework.

The students seem to feel that they have the opportunity to develop creatively as well as academically. For example, a lot of GSD UG students are actively involved in trying to influence for the better the Warwick estate with a sustainability agenda. In terms of the scheduling for the MASc, central timetabling determine the class times. For term 1, there will be around 10 contact hours per week. Term 2 will depend upon optional choices and from the Easter break it will become much more flexible.

Hi Chidi! Most of our applications to date are from international applicants, and this is really important to us. They come from all over the world. Of course, the main issue relates to funding opportunities. We hope to increase these over time - but for this year (we only started the program a couple of months ago) we have funding for the Leverhulme scholarships and various other scholarships through the school (Midlands 4 Cities and the Chancellor's scholarships, for example). Many of these have funding opportunities for international applicants. We have also supported international applicants who have funding from their own governments or from, for example, the Commonwealth scholarships. International applicants can also apply for the Leverhulme scholarships, but we can only give one of these per year to international researchers because of a limitation set by the funder, rather than ourselves. Does this answer your question, Chidi?

Hi Nicole, just following on from what Amalia has said, our undergraduate students in GSD go on to a wide variety of job roles/industries after graduation. We're still awaiting Graduate Outcomes data (as the undergraduate courses are still fairly new), however, from our own research I'll provide you with some examples of job roles: Consultant, Risk Analyst, Energy Procurement Coordinator, Social Value Advisor, eCommerce Trading and Marketing Executive (and that's just to mention a few!). In terms of sectors: Recruitment, Public Policy, Accounting, Retail, Think Tank, International Affairs... I could go on! Hopefully this gives you a flavour of what our students do next

Hello Ji-ae! Yes, for the scholarships, the references would need to be received before the deadline. They form an important part of the selection process. Deadlines were very tight this year because it is the first time the programme has operated. From next year, obviously, people will be aware of the programme and the opportunities over a longer period and will be able to prepare better. But yes - you will need to submit the references with the application.

Hello, yes, you can certainly customise your PhD to your interests bearing in mind that it is an interdisciplinary programme and therefore needs to straddle at least two disciplines and involve two supervisors. The key is to find supervisors in your area of interest.

We would advise that the application to the PhD programme is made this week to allow for references to be requested, written and submitted. In terms of your proposal, this is part of the scholarship application and can be submitted any time up to the closing date/time. Although you may wish to submit a little earlier to make sure that you don't run out of time completing and uploading documents.

Hi Tomas! An important question for you to consider in terms of how your research ideas may fit with GSD would be the extent to which you want to push your thinking in an interdisciplinary way. If your project was something that fitted into a single discipline (e..g Economics) model, then GSD may not be the best place for you - although someone from GSD could potentially contribute to your supervision within another department. But if you wanted to consider your topic from a different perspective in addition to the economic so that you would bring an interdisciplinary or transdisciplinary slant to it, then GSD would be a good place to consider. We would work to bring in a supervisory team to support the project holisitically. Does this help?

We have a co-supervisory arrangement where we create bespoke arrangements for each PhD programme with supervisors contributing different amounts of time depending on what is needed. It can be a challenge in single discipline departments for supervisors to work together collaboratively on interdisciplinary projects, but all our staff on GSD/IGSD and the wider school are familiar with this kind of research themselves and are used to respecting and understanding the challenges involved. We will also develop a strong supervisory support network as well, where we also engage reflexively on our own positionality and how we support PhD students. Does this answer your question, Patience?

Hi Xintong! You will have 2 or even 3 supervisors who will be expected to support different aspects and approaches within your research project. We expect all projects within GSD to be interdisciplinary and so this will be a very common situation. The supervisors are all used to working with transdisciplinary projects and so will also be prepared, when necessary, to enlist the support of other people who will give you guidance. Also, in developing your own autonomy as a researcher, you will learn to network and get support from people where gaps appear in your knowledge. I hope this helps!

Hi, we certainly value professional experience and this is incorporated into our transdisciplinary approach. Each student would bring something to the group and 'real-world' experience is highly valued and relevant.

This is something to discuss with your supervisor as your project develops. The most important thing from a GSD perspective is that you want to push your research into areas that extend beyond one disciplinary approach - but this will be discussed with you as your project develops.

Hi, the projects are purposely broad with the scope to take it in your own individual direction and this can be discussed with the supervisors to ensure they would be able to supervise effectively in the direction you plan to go with it. In terms of additional supervision, if this is appropriate we can look at putting this in place.

Hi Massimo, thanks for your question. You're correct - for the PhD the core module is the only planned module. You will also have a personal and professional development plan to complement your research. The rest of your time is spent undertaking your research and having supervision with your supervisors. I hope this might be helpful!

A background in Law will be a great asset because you will already have familiarity with really important social and political issues that underpin a lot of discussion within GSD - rights, governance etc. We expect students to come from lots of different backgrounds - like our UG students. It is absolutely right for Law students, too!

Hi Hala! We have a dedicated members of staff, Bodrun Nahar, whose job it is to support students at all levels in their career development. I think that the opportunities are extensive and likely to increase further as the Green Economy approach strengthens. You will be given the opportunity to explore career pathways in the course and to undertake modules or gain experience that actively support what you want to do. There are so many varied options, it is difficult to generalise - so the key point is really that you will have the time within the course to dedicate to this specific future path in a way that is not always possible in programmes that are less directed towards practice and practical applications of your studies.

Hi there! We have recently had 13 applications so far for the PhD programme, due to some international scholarship deadlines

Nicole, it could be either - your could choose to work on something related to biodiversity or water or energy, or you could choose something more related to the social domains of sustainability. We have colleagues working across all areas and so you would define your project and we would aim to find someone to support you.

Hi Patience, We do advise that you contact your preferred potential supervisor(s) with a clear but short proposal (500-1,000 words) along with your CV and any relevant transcripts prior to making an application.

Hi Alban, we give you some broad guidelines but your focus is up to you and if that is what interests you most then go for it. You may wish to think about which options you would wish to take and the capstone project and how it all ties together and relates. My colleague, Mandy, is a historian so may be able to advise too.



If I did not find the potential supervisor until the deadline, is it possible to apply without potential supervisor for PhD program?

If you are applying for the Leverhulme programme grants, then we would need you to have been in contact with a potential supervisor. However, if you send in an outline to the general enquiry account, it can be forwarded to see if suggestions can be made to help you identify someone. But it is also best for you, too, to talk to a potential supervisor to make sure that you have a good 'fit' with each other!
