DIRECTORS' MESSAGE: TWO YEARS OF ACCOMPLISHMENT AND INNOVATION

Welcome to the bi-Annual report of the Institute of Health. These were two years of great activity and innovation that helped to consolidate the Institute as one of the most thriving and dynamic realities of Warwick University. It is therefore with satisfaction and sense of pride that we report here the extent and breadth of the Institute's achievements activities.

An invaluable incubator of new initiatives and a meeting point where the creative friction between people and disciplines generates new ideas and innovative projects.

The Institute of Health was founded in 2001 to promote, support and develop social science research in health and social care. It is based within the School of Health and Social Studies in the Faculty of Social Studies and operates in close collaboration with the Warwick Medical School and other departments of the University which deal with healthcare issues. The Institute promotes supports and develops social science research in health and social care.

It also delivers teaching and training on social science aspects of health. Over the years, however, the Institute has also become a primary centre for the promotion and nurturing of multidisciplinary research across the University and in partnership with external bodies and interested members of the public. Thanks to its dynamic way of operating, the Institute has been extremely successful in triggering new cross disciplinary ventures and collaboration. These have been then either accommodated within its permanent structure (like the new Centre for the study of the Built Environment, Health and Well Being) or further developed by the participants in their own "home departments". In both cases, the Institute has positioned itself as an invaluable incubator of new initiatives and a meeting point where the creative friction between people and disciplines generates new ideas and innovative projects. The number of funded projects, publications and conference papers that this activity has generated is the best evidence of the important role the IoH plays within the University.

A wide range of creative and productive initiatives

The content of this report shows that the last two years have been characterised by a flurry of productive and creative initiatives. Thanks to the effort of its members, the IoH has organised an impressive number of seminars, conferences and research group meetings. A few to highlight would be firstly the internal poster event in early 2009 that brought together research of staff and students across the university in the Digital Laboratory with accompanying presentations involved 85 posters . This was a highly effective and innovative way to network and meet new collaborators whilst showcasing work to the many visitors. Another notable initiative was the ESRC Seminar within the series on Global Health and Human Rights. This was video linked to the University of Cape Town for the day and involved the presentation of papers from Warwick and Cape Town with questions and discussion across the two sites.

The Institute's members also contributed to the scientific standing of the university through a number of peer reviewed articles and books. Three major volumes have been published in 2009 and two more in press for publication in 2010. Many of these stem directly from Institute's

activities. For example, Hannah Bradby and Gillian edited book on War Gender and Suffering (Ashgate) was the outcome of an event held to commemorate the intellectual legacy of the late Professor Emerita Meg Stacey.

The continuing success of UNTRAP

In the last two years, UNTRAP continued to expand and flourish involving users and carers in teaching and research in health and social care. We continue to induct new members and run training courses to support them to participate in research and teaching. Most recently 12 members of UNTRAP attended a day-long training course on research which included presentations from more experienced members on shaping research proposals and sitting on review boards.

New developments

The last two years have also seen some very important new developments. The most notable was Elizabeth Burton joining as the IoH Professor of Sustainable Building Design, Health and Well Being. This was a joint appointment with Engineering and allowed Prof. Burton to house at Warwick her Wellbeing in Sustainable Environments research group. WISE conducts ground breaking, world leading research in the area of the Built Environment, Health and Well Being, a topic attracting increasing interest and where research can have a direct and beneficial impact on the wider population. Besides increasing the opportunities for creative crossover between disciplines, the activity of WISE is bound to generate further interesting developments and research opportunities. Clear evidence is the decision of Dr David Ormandy, currently Professorial Fellow in Housing Standards and Health in the School of Law, to join the IoH from February 2010 after taking retirement.

Farewells and welcomes

One of the reasons for the success of the institute is its dynamic nature. Changes are therefore a natural occurrence at the IoH. While we are always a bit sad to see people move to new challenges, this is also the opportunity for the IoH to reinvent itself through new and enthusiastic members. Since the last report, Hannah Bradby resigned as Co Director, although luckily enough her collaboration with the IoH continues unabated. She was replaced at the end of 2008 by Dr Davide Nicolini, who brought his expertise in innovation and knowledge translation in organisations and a closer linkage to Warwick Business School and in particular the research centre Innovation, Knowledge and Organisational Networks Research Unit (IKON). Dr Janet Read and Dr Eileen McLeod have both retired but have been continuing to supervise PhD students and undertake research as Reader Emeritae. Jas Bains ably took on the post of Administrator of the Institute of Health in October 2008. A number of staff, Christine Coe, Dr Andrew Gibson, Karen von Rompaey, and Dr Judith Purkis have left and are furthering their careers, building on the experience gained within the IoH. We thank each of them for their unique contribution. There have been some changes of membership to the Advisory Group and Management Committee. We thank in particular Sir Donald Irvine and Professor Emerita Mildred Blaxter and Professor Robin Wensley for their support and advice over the years.

the range of ways in which we support the meeting of minds both within the University and in the larger international academic and practitioners' community. In this sense, we aim to extend our international collaborations and increase our outreach activities towards the local community of healthcare practitioners. Finally, one of our main goals for the forthcoming period is also to further consolidate the activity of UNTRAP and ensuring its long term sustainability without altering its mission and ethos. We believe that this is possible if we help the University realise its current contribution and potential benefit especially when end user participation is becoming a required feature of all healthcare research projects.

In sum, we look forward at the next two years with unabated enthusiasm. We are convinced that academic excellence stems primarily from passion and curiosity and not from pressure or ambition, and for this reason we will continue to build on our inclusive, informal and multidisciplinary ethos and our agile organisation. For the last ten years the Institute's activities demonstrated that modern academic work, creativity and enjoyment can go hand in hand. 2.4 Visiting Fellows to the IoH 2007-9

There have been a number of visiting fellows to the Institute of Health who have contributed to the research ethos and activities. Some have had external funding and other have been Visiting Fellows to Warwick through awards made by the Institute for Advanced Study which was set up at Warwick in 2007.

Professor Varda Soskolne, Professor of Social Work, Bar Ilan University, Israel spent six months of a sabbatical at the Institute of Health in 2007. She came to the IoH through the Social Work and Global Health Inequalities network convened by Eileen McLeod and Paul Bywaters. She gave a number of presentations as well as giving support to a number of students and colleagues.

Dr Sahar Almakhamreh, Assistant Professor of Social Work, AlBalqa Applied University, Jordan was the recipient of a BA/ESRC/AHRC Visiting Fellowship for Scholars from the Middle East and South Asia during the summer of 2008 to work with Gillian Hundt. During this time she conducted a literature review on the current status and conditions of Iraqi refugees in Jordan and the models of social work intervention that could be suitable for addressing their needs. She also did some preliminary work on a pilot training intervention for social work and nursing students on the conditions of Bedouin in Jordan as part of the Bedouin Health project underway in Jordan, led by Fadia Hasna and Gillian Hundt.

Ms. Maha Damaj, UNICEF Child Protection Officer, Lebanon, visited in 2007 to complete her thesis revisions and develop collaborative links with IoH and SWELL. She is now based in Sri Lanka dealing with the aftermath of the prolonged civil war and has been awarded her doctorate from the London School of Hygiene and Tropical Medicine.

2.5 Institute for Advanced Study (IAS) Visiting Fellows

The Institute for Advanced Study was established at the University of Warwick in 2007 and funded Visiting Fellowships are awarded to candidates nominated by cross departmental groups in the University. In addition, incubation awards are available for the development of new areas of research. Staff at the Institute of Health has been awarded and hosted a number of these Fellowships and an incubation award.

Dr. Sarab Hanoush has been a CARA/Institute for Advanced Study,(IAS) Fellow in the Institute of Health during 2008-9 continuing into 2009-10. She is a community dentist who was a member of the Faculty of Dentistry at the University of Baghdad. She has undertaken some research and IT training and has been working with Gillian Hundt within the Bedouin Health Project in both Jordan and Lebanon, undertaking some dental health assessment and dental health promotion interventions in Bedouin schools. She has undertaken two field trips and attended a project meeting in Lebanon.

Professor Elizabeth Burton, Professor of Health, Well Being and the Built Environment from Oxford Brookes was an IAS Fellow at the Institute of Health during the autumn of 2008-9. She developed collaborations with a number of colleagues in Warwick Medical School, Psychology, Engineering, and SHSS and gave a seminar as well as convened an international symposium. She has joined the Institute of Health in a joint appointment with Engineering and SHSS as the Professor of Sustainable Building Design and Health and Well Being (80%) in September 09.

Professor Debra Roter is Professor of Health, Behaviour and Society at John Hopkins University, Baltimore, USA. She visited the Institute of Health in June 09. Members of SHSS (Blackburn and Seers) were part of the organising committee, lead by the Medical School, for Professor Roter's short-term visiting fellowship (funded by the Institute for Advanced Studies). Her visit aimed to develop research collaborations on doctor-patient communications. During her visit she met with academics from the Institute of Health to discuss research and gave a workshop, attended by 40 researchers, on *Hybrid Methods of Communication Research: Going Beyond Qualitative/Quantitative Paradigms*.

Professor Jermone Bickenbach, Queens University, Ontario, Canada and the World Health Organisation: visited the school for two, two-day meetings in November 08 and March 09 as part of a new, multidisciplinary research network meeting (funded by an Institute of Advanced Studies incubation award). These meets were to develop work on *Childhood Disability: measurement, prevalence and social circumstances in different national contexts*. In addition to working with Institute staff (Blackburn, Read and Spencer), he gave a lecture entitled *Kids with Disabilities: Definitions, Classification and Human Rights*.

6. RESEARCH PROJECTS DURING 2007-2009

The quality of life of visually impaired children - investigation and development of a novel vision-related quality of life instrument (2007-2010)

Funding body: The Guide Dogs for the Blind Association

PI : Jugnoo Rahi, Institute of Child Health, UCL

Serious visual loss during childhood is known to pose significant educational, employment, personal and social challenges throughout life. Nevertheless the perspective of children about the consequences of their visual loss and of their treatment to preserve or improve their sight has not been widely investigated. Vision-specific subjective outcome measures are needed which can differentiate between visually impaired children and capture their concerns. There are increasingly important and diverse applications of such vision-related quality of life (VRQOL) instruments. They can be used effectively in evaluating the broader benefits of new treatments to preserve and improve sight; applied in planning and provision of rehabilitation, education and social services; used in clinical settings to aid in managing individual patients; applied in population assessments of disease burden; and used for prioritising the agenda for service provision and for future research on visually impairing disorders of childhood. Prompted by the experiences of the visually impaired individuals with whom we work, and knowledge of current practice in other areas of child and adolescent health, we propose to develop the first VRQOL instrument for self-completion by children.

Evaluation of Rosetta Life Social Arts Activities for the Pan Birmingham Palliative Care Network (2008/2009)

Funding Body: Pan Birmingham Palliative Care Network

Rosetta Life is a UK leader in delivering innovative arts activities to those receiving Palliative Care through opportunities for creative expression through various art forms and via different platforms to share their output. The NHS Pan-Birmingham Palliative Care Network commissioned an evaluation of this work, focusing on partnership projects in the Midlands during 2008-09. These are: a drama project involving hospice users and Birmingham Repertory Theatre; two movement projects with people who have severe motor disabilities, and a film about living with life-threatening disease around the clock. Research methods included interviews with participants, carers, staff and artists, alongside observation and feedback from audiences and staff.

A Study of the Ethical Understandings of Clinical Practice of Non UK Qualified Doctors (2008-2009)

Funding body: General Medical Council

PI: AM Slowther (Warwick Medical School)

Co-Investigator: Gillian Hundt (Institute of Health)

The GMC commissioned a research study to explore the experiences of International Medical Graduates, including graduates from the European Economic Area, in adjusting to working within the GMC's professional and ethical regulatory framework. The study used a mixture of qualitative and quantitative methods and included a review of the information available to doctors wishing to apply for registration with the GMC. The study findings showed that non-UK qualified doctors have difficulty accessing information and support that would help them to apply GMC guidance in practice. The study made several recommendations including the provision of targeted information, in post induction and training, and ongoing mentoring for doctors beginning work in the UK having qualified in another country. A smaller sample of UK qualified doctors showed that this support would be of general benefit to all newly registered doctors but is more likely to be already available to UK qualifiers. Presentations have been given to the GMC, and the Association of Medical Education as well as at international conferences.

Khat and Social Identity in Uganda (2007-2009)

Funding body: ESRC

PI: Dr Susan Beckerleg (Institute of Health)

The production and consumption of many psychotropic substances have been attributed with the power to destroy individuals, communities and even nations. For example, heroin production in Afghanistan and cocaine production in Colombia provide a good income for producers, but undermine the rule of law and civil society in ways that are unacceptable to the international community. Some academics, policy makers and lobbyists have made similar claims for khat (*Catha edulis*), a plant that acts as a stimulant when its leaves or stems are chewed. This study was completed in December 2009 and involved fieldwork in Uganda with khat producers and users. A book manuscript has been submitted to the publishers and papers given at conferences.

Evaluation of The Apnee Sehat Diabetes/Metabolic Clinic in the Gurdwara (2007-2008)

Funding body: Sanofi –Aventis, Charitable grant

PI: Chris Coe (Institute of Health)

The prevalence of premature diabetes and heart disease in the south Asian community (ethnic groups originating from the Indian subcontinent) is six fold higher than the national average and rising. This was the basis for the development of a

healthy lifestyle intervention programme for the south Asian community in a Midlands town whose community is predominantly, eighty per cent, of Sikh Punjabi origin. This particular community currently holds the largest concentration of Punjabis in one town outside London. The need for a diabetes/ metabolic clinic was identified by the community, and commenced in January 2007.

Evaluation of Contact & Connect for Age Concern, Coventry

Contact & Connect is a project, commissioned by Older People's Partnership, Coventry that aims to provide a single gateway to a range of services designed to support older people to live independently in their own homes. The project has two-year funding from Community Services and Supporting People. The evaluation is designed to investigate the effectiveness of the project from the perspectives of current funders, partner organisations and older people who have received the service. It comprises analysis of documentary data, interviews with funders and partner organisations, and telephone and face-to-face interviews with older people.

This study aims to assess and improve access for Bedouin in the North East Badia of Jordan and the Bekaa Valley of Lebanon to health care. The two research teams in Jordan and Lebanon have completed data collection and analysis as well as dissemination to policy makers, health professionals and the Bedouin communities. Pilot interventions in the areas of school based dental health promotion and training of health professionals are in progress.

Evaluation of the Role and Impact of User Representation and Involvement in Neonatal Network Boards (2006/2008)

Funding body: BLISS, WMSSA, Grace Research Fund

PI: Gillian Lewando-Hundt (Institute of Health)

Co-Investigators Dr Loraine Blaxter and Mr Andrew J. Gibson (Institute of Health)

The research team worked in partnership with the members of Neonatal Network Boards during two years. A national survey was completed twice by all neonatal network boards which established the different modalities of user involvement in use during the two years. Two more detailed case studies were undertaken to gain a more nuanced understanding of the process and mechanisms involved in the role of users and professionals on Neonatal Network Boards. A conference paper was presented at the British Medical Sociological Association Medical Sociology Group Annual Conference in September 2007 and many presentations were given to health professionals and network members.

Quality and continuity of End of Life care between home, nursing homes and district hospitals: A nurse led action research project examining patient pathways from home or nursing homes via A&E wards (2005-2008)

Funding body: The Burdett Trust for Nursing Grant

PI: Dr Ann Jackson (Warwick Medical School), Professor Gillian Lewando-Hundt (Institute of Health)

This nurse led action research will address several critical issues in end of life care occurring in nursing homes, A&E departments and wards in a local hospital. The two main areas of research will be decision making at the time of referral to A&E via the ambulance service and the quality of end of life care given in A&E. Its ultimate aim is to ensure that patients and relatives experience good end of life care in an environment which is appropriate to their needs. The action research will identify patient pathways and critical junctures where interventions could improve care. The findings will play an important part in identifying the resources needed currently, and in the future, to deliver quality end of life care. The findings from this locality will be transferable and comparable to other local district hospitals.

This ESRC funded seminar series has brought together academics, practitioners, managers and researchers from the UK and across the world to explore and develop the agenda for social work research on health inequalities. Attended by invited colleagues including a group of post-graduate research students the seminars have produced in a unique archive of over 30 papers, which have been stored on the Social Work and Health Inequalities Network website in the Institute of Health at Warwick (www.warwick.ac.uk/go/swhin). To date, 5 articles have been accepted for publication in peer reviewed journals.

This seminar series took place in Liverpool, Edinburgh and Warwick with two day seminars in each place. It brought together researchers, policy makers and students working in this emerging area. An edited book is being submitted in early 2010, and a special issue of Social Science and Medicine on this topic drawing on some of the papers is in progress.

Evaluation of the stop smoking service run by the national organisation QUIT for young people who smoke (2007-2009)

Funding Body: Cancer Research UK

PI Dr Wolfgang Markham

The trial was designed to answer four questions:

1. How many more quitters are generated by attending smoking cessation groups run by stop smoking advisors than by receiving one-to one support from stop smoking advisors?
2. Do smoking cessation groups affect smoking prevalence at the school-level?
3. What features distinguish participants who stop smoking from those who try and fail? In particular, what is the concurrent and predictive validity of different dependence scores amongst young people who smoke, as shown by the association of the scores with baseline cotinine and carbon monoxide and the degree to which these scores predict likelihood of success in quitting?
4. How is smoking prevalence related to young peoples' perceptions of their relationships with their carers and their perceptions of their relationships with schooling and schools?

Mapping Nurse Led Social Care Interventions in Emergency Departments (EDs) across the UK: A survey and Systematic review of their objectives, extent, organisation and function (2007-2008)

Funding body: The Burdett Trust for Nursing

PI and Co-applicants: Joint PIs Dr Eileen McLeod and Dr Joanne Fisher, Co-Applicants: Prof Paul Bywaters, Prof Matthew Cooke, Mr Gary Swann.

The study represents the first UK survey of the objectives, extent, organisation and function of nurse led ED based social care interventions, including multi-professional social care teams, as an essential basis for further testing and developing this model of intervention. It comprised the first systematic UK and international literature review of nurse led ED based social care interventions in emergency care, and of UK locality based evaluations, identifying key lessons for policy, practice and research. In

collaboration with key stakeholder representatives, it developed, disseminated and reviewed an evidence based checklist of good practice, derived from the study.

The Organization and Management of Clinical Trials (2007-2009)

Funding Body: EPSRC – the Warwick Innovative Manufacturing Research Centre

PI and co-applicants: Jacky Swan (Warwick Business School - WBS), Maxine Robertson (Queen Mary University of London - QMUL)

Research Fellow: Sarah Evans

This research responds to growing concerns expressed by UK scientists, clinicians and industrialists about the ‘translational gap’ between basic scientific discovery and innovations that will directly benefit patients, and about the decline of the UK’s clinical research base. The management of clinical trials is central to closing this gap and entails complex networks of relationships, often on a global basis, and increasingly involving large clinical research organizations and/or other service providers. This research, in collaboration with the Institute of Clinical Research, the Warwick Clinical Trials Unit and the Association of the British Pharmaceutical Industry, provides an extensive, systematic study and mapping of the different approaches to managing and organizing clinical trials in the UK context and the challenges these pose for key stakeholders involved. The research will develop theory on networked innovation using clinical trials as an exemplar.

Improving the Capacity of Healthcare Organisations to Act on Evidence in Patient Safety (2008-2009)

Funding body: EPSRC –Warwick Innovative Manufacturing Research Centre

PI and Co-applicants: Davide Nicolini (WBS), Justin Waring (Nottingham), Peter Spurgeon (WMS) Jacky Swan (WBS) and Alessia Contu (WBS)

The project aims to investigate the practical problems and available solutions for healthcare practitioners doing Root Cause Analysis, a widely used methodology for reviewing patient safety incidents and preventing their re-occurrence. We aim at furthering the understanding of how this method is applied on the ground, what are the challenges it poses for the investigators and for the organization, whether it is perceived as useful, and whether it generates organisational learning. The research will be conducted by researchers from the Warwick Business School, the Warwick Medical School, and the School of Sociology & Social Policy of Nottingham University. The team will be actively supported by high level international Scientific Advisory Panel

Understanding the Historical Evolution of Pharmacy Practice. A Cross National Study (2007–2008)

Funding body: Warwick Business School Research and Development Fund

PI: Davide Nicolini

The aim of the project is to investigate the evolution of pharmacy work in the UK, comparing it with the situation and the historical trends in other OECD countries. The research will be articulated in two main stages: the investigation in the UK and the cross national comparison. The UK study will last 7 months and will be based on a combination of expert interviews and collection of historical and archival data. This stage will be carried out in parallel with the other national studies that will be carried out by the University of Bergamo (Italy), the Goteborg Research Institute (Sweden), and the University Of Alberta School Of Business (Canada). The cross national comparison will be carried out through two workshops in Bergamo (Italy) in October 2007 and Warwick University (UK) in March 2008. In 2005 the University of Warwick received funding for 14 Academic Fellowships in key research areas of strategic importance. One was granted to Swan in WBS for a fellow in Managing and Exploiting Knowledge to focus on the translation of scientific knowledge into new forms of medical treatments and practices. The successful candidate (Davide Nicolini) joined Warwick Business School's 'Innovation, Knowledge and Organizational Networks' research centre (IKON) and is playing a key role in forging IKON's future research strategy in health innovation and in developing interdisciplinary links with others departments (WMG/WIMRC and WMS) and other institutions (e.g. Nottingham University).

Net Effects: The Internet, Health and Health Care (2006-2009)

Funding body: NCCRC

PI: John Powell (WMS)

A 'mixed methods' design using both qualitative and quantitative methods to identify and understand: the motivations and outcomes of internet health information use, the use of virtual communities in relation to long-term chronic illness, the role of the internet in supporting healthcare decision-making. The findings will inform future service provision by identifying how the internet can be harnessed as a tool to improve public health, to support health and social care, and to enhance patient and carer experience. The main partner for this research is NHS Direct New Media.

Knowledge Management Systems For 'Lean' Healthcare

Funding body: EPSRC – the Warwick Innovative Manufacturing Research Centre

PI and Co-applicants: Davide Nicolini (WMS), John Powell (WMS), Laura Martinez-Solano (WMG)

This scoping project investigated Knowledge Management concepts, policies and practices within the UK healthcare sector in order to identify priorities for future R&D

activity. The study explored the ways in which KM is being perceived (as useful or otherwise), and surveyed the types of KM initiatives that exist both at a local and national level. The project incorporated literature review, stakeholder interviews, international benchmark, and interviews with NHS staff in the West Midlands. We worked closely with the NHS Institute for Innovation and the final project seminar was held in conjunction with the NHS Institute.

Development of a Survey on Services for Disabled Children (2008)

This research was carried out with NatCen (lead organisation) and the University of Bristol. 8.1 Applied Performance Group in Health and Social Care (previously Applying Theatre to Health, Medicine and Social Care)

The Applied Theatre Research Group brings together people who have developed a shared interest in the uses of applied theatre in research and education. It grew out of work carried out for the SASPI (Southern Africa Stroke Prevention Initiative) by Dr Maria Stuttaford and Professor Gillian Hundt after collaborating with Claudette Bryanston on methodologies and approach to using participatory theatre. The project used community theatre and storytelling at village meetings in order to disseminate and validate the research findings from this project. Other more recent projects have included a Wellcome Trust funded play on the dilemmas of genetic screening in early pregnancy, developed from ESRC funded research on this topic, preparatory developmental work on end of life care developed from the Burdett Trust research

project on this topic, and an evaluation of the work of Rosetta Life in the West Midlands.

8.2 Health Inequalities, Equity and International Health

Convenor: Clare Blackburn, Associate Professor, Institute of Health, SHSS

Much of the work of this group is concerned with understanding the way social and material circumstances shape health, health behaviour and access to health care across the life course. It has a particular interest in the implications for international, national and local health policy and practice. Recent research includes work on child health and child poverty; social and material circumstances of households with young children; disabled children and their households; incidence and prevalence of child disability; carers and access to ICTS; poverty and health behaviours, and social work and health inequalities. A number of researchers carry out work on social capital, men's health inequalities. Alan Dolan is planning work on further work on fatherhood and also on local approaches to tackling health inequalities. An award from the Institute for Advanced Study to Clare Blackburn provided for a Visiting Fellow Louise Seguin from Montreal and a meeting of an international research network on children and health inequalities was held in November 2009.

11. UNIVERSITY/USER TEACHING AND RESEARCH ACTION PARTNERSHIP (UNTRAP)

UNTRAP has continued to expand its activities and membership. There are currently 100+ members who are users and carers who would like to take part in teaching health professionals of tomorrow and also take part in research activities. Funding has been obtained through the Higher Education Infrastructure Fund until 2011 through the heading linking to communities of practice and this support funds an UNTRAP coordinator and workshops to train UNTRAP members and to involve stakeholders such as researchers, or community organisations in the voluntary sectors. An increasing number of organisations are becoming linked to UNTRAP and partnership working is developing. UNTRAP members participate in teaching directly on social work courses at Warwick and Coventry and in Warwick Medical School. They are also involved in admissions, assessment and curriculum development. Research activities include being members of funding committees and research advisory groups as well as increasingly being involved with the development of research proposals. The Steering Group has three sub-groups on teaching, research and recruitment with academics and UNTRAP members working together on each of them. This is a unique mechanism within the UK and has been commended as an example of innovative best practice by the General Medical Council and also the General Social Care Council.

12. UPDATE RESEARCH BRIEFING

We continue to publish UPDATE both on the website and in hard copy. This profiles research in different areas with the text written by a sciencewriter who reads the research papers and interviews the individuals engaged in this work. In 2007 – 9 UPDATE featured research on health and human rights, social work and health inequalities. During 2010 issues are planned on Health Well Being and the Build Environment and on Knowledge Translation. UPDATE is also funded by the HEIF grant.
