CPMS NOTICE: Only add participants to the CPMS/EDGE when you recevie a randomisation notification. Enter the month of randomisation for 'recruited' and 'consented'. We will confirm research activity on 1st every month. I.e. if you consent someone in June and they are randomised in July, all activity for this participant **should be entered as July.** This ensures we are recording the correct arruals at your site.

At the workshop, we will provide an update on iRehab recruitment and screening, tips to optimise recruitment and training to address patient preferences. RECRUITMENT: As of 28th April 2023, a total of **51** participants have been randomised and **26** patients registered awaiting baseline data collection before randomisation.

Recruitment to date target: 51/70 (73% of monthly recruitment target)

Recruitment total target: 51/428 (12% of overall recruitment target)

Well done to our top recruiters this month: Southampton General Hospital

Well done to Altnagelvin Hospital, Craigavon Area Hospital and Musgrove Park Hospital for recruiting your first participant this month

Thank you to all sites for continuing to screen for iRehab, a total of 335 people have been screened so far.

TRIAL TIPS

Step One- Screening: Avoid where possible 'No reason given' when documenting why patients do not want to take part in the trial. It is helpful for us to know specific reasons so we can monitor patient preferences. "Does not want to give reason" is acceptable.

If the patient does not speak English, they can still participate in the trial if they have a friend/family member who is able to translate for them/ willing to attend intervention sessions.

Step Two- Consent: Try and consent the patient and register them <u>within a short period</u> of each other - this allows the patient to receive study documentation as soon as possible and be kept up to date.

Step Three- Registration: Ask patients for multiple contact methods including an <u>email address</u> if they have one. Enter their preferred method by adding this as a comment by selecting the three dots on the contact details form, next to the telephone number/mobile number or email address. Enter a comment such as 'Preferred method: email, telephone or text. May not answer phone calls to unknown numbers and is only available via phone in the afternoon' then select 'Post'.

Ad Hoc- Readmission: If you are notified of a readmission, please complete the readmission form on the iRehab database. Date of discharge can be added at a later date when known.
