UPDATES

REMINDERS

Screening:

- 1. When selecting 'No reason' as to why the patient is not coming into the study. Please only select this if the patient does not want to give a reason and try to find out where possible why the participant does not want to take part.
- 2. Please record the language spoken if the patient does not want to participate due to not speaking/ understanding English.

Registration:

Consent form, contact details and co-morbidities form <u>must be 100%</u> complete for the participant to be officially registered and questionnaires triggered. If they are not 100% the participant will not be 100% registered.

TOP TIP: Complete these forms as soon as possible following consent, this allows the team longer to collect baseline data. On a few occasions we have had less than 10 days to contact participants which means fewer attempts can be made. We have up to 16 weeks from hospital discharge to randomise your participant, so long as the ED5D5L is complete. If your patient is approaching close to this timeframe (10-12 weeks discharge), please encourage them to complete the questionnaires as soon as possible. This means even if we cannot make contact with them, they can still be randomised.

Recruitment total target: 113/428 (26% of overall target)

Want some helpful tips on recruiting participants for iRehab, check out our tip guide!

CPMS REMINDER: Only add participants to the CPMS/EDGE when you receive a randomisation notification. Enter the month of randomisation for 'recruited' and 'consented'. We will confirm research activity on 1st every month. I.e. if you consent someone in June and they are randomised in July, all activity for this participant **should be entered as July.** This ensures we are recording the correct accruals at your site.
