Welcome to the seventh iRehab trial newsletter. We hope these updates are useful but do let us know if there are any areas you would like us to focus on. Previous newsletters can be found on our [website](#).

CPMS REMINDER: Only add participants to the CPMS/EDGE when you receive a randomisation notification. Enter the month of randomisation for 'recruited' and 'consented'. We will confirm research activity on 1st every month. I.e. if you consent someone in June and they are randomised in July, all activity for this participant **should be entered as July**. This ensures we are recording the correct accruals at your site.



UPDATES

Substantial Amendment 02 has been circulated to your trust and is awaiting local approval **BEFORE** it can be implemented locally. This will be implemented on **11th August**, if we do not hear from you before hand. Documents impacted:

IREHAB DROP-IN SESSION RECAP: 3rd July

Thanks again to our guest speaker Vicki Waugh from Royal Liverpool Hospital last month. Some helpful tips:

1. Screening: team go round patients every day and screen all.
2. Approaching patients:
 - (A) Build a relationship with patients by visiting participants on ward, give them PIL and discuss study- highlight the office number on the PIL for queries.
 - (B) Good communication is essential: Explain next steps/what will happen when patients are discharged. Expect a call about iRehab once they're home. Explain that randomisation isn't immediate. Find out when/how best to contact potential participants.
 - (C) Strategy for contacting potential participants: Log how many times contact has been attempted. Limit to 3-4 times contact attempts.
3. Patients seem to value the link to the hospital that iRehab provides.

TOP TIP: Write handover emails prior to any A/L- inform patients when there is leave when following up.

!!! Reminder: The remote lunch drop-in session with iRehab scheduled for Tuesday 1st August has been cancelled. We plan on holding a larger event, beginning of September to provide you with a study update after our pilot phase has ended. Details of this event will be circulated in due course.

RECRUITMENT: As of 31st July 2023, a total of **95** participants have been randomised and **23** patients registered awaiting baseline data collection before randomisation.

Recruitment target to date: 95/139 (68% of monthly target)

Recruitment total target: 95/428 (22% of overall target)

Well done to our top recruiter this month: **Kingston Hospital**

Congratulations to **Kingston Hospital** and **Salford Royal Hospital** for recruiting your first participant this month

Thank you to all sites for continuing to screen for iRehab, a total of 760 people have been screened so far.

DATABASE GUIDANCE

1. *Screening*: Does the participant want to take part in iRehab? Select 'Pending' if this is not known at the time of completing the onboarding form.
2. *Registration* [Consent, Comorbidities, Contact Details]: These will be unlocked when the screening form is complete for an eligible participant who wishes to take part.
3. *Registration* [Consent, Comorbidities, Contact Details]: The consent form, contact details and co-morbidities form MUST be 100% complete for the participant to be officially registered and questionnaires triggered. If they are not 100% the participant will not be 100% registered
