Invoicing. If you are activitely screening post randomisation of a participant you can invoice

aderse event forms and hospital readmission forms for all participants following consent. For the hospital readmission form, date of dischrge can be added at a later date when known.

Multiple contact methods for participants. Please add more than one contact method and more than one preferred method of contact. Only including one number and one method (e.g. email, text, phone, NOK, whatsapp) extremely limits us in making contact with the participant.

API Scheme. Just a reminder that iRehab is open to the NIHR associate PI scheme. The Associate PI Scheme is a six month in-work training opportunity, providing practical experience for healthcare professionals starting their research career. Co-enrolling. Please let us know of any trials that are currently running at your site that iRehab should co-enrol with. RECRUITMENT: As of 29th September 2023, a total of **131** participants have been randomised and **20** patients registered awaiting baseline data collection before randomisation.

Recruitment target to date: 131/197 (66% of monthly target)

Recruitment total target: 131/428 (30.6% of overall target)

Want some helpful tips on recruiting participants for iRehab, check out our tip guide!

CPMS REMINDER: Only add participants to the CPMS/EDGE when you receive a randomisation notification. Enter the month of randomisation for 'recruited' and 'consented'. We will confirm research activity on 1st every month. I.e. if you consent someone in June and they are randomised in July, all activity for this participant should be entered as July. This ensures we are recording the correct accruals at your site.
