Warwick Economics MSc Checklist

Induction

- Have you read the <u>Getting Started</u> section of the MSc Handbook?

Modules and Classes

- Have you carefully considered your optional modules and registered for your modules via eMR? (<u>warwick.ac.uk/evision</u>)
- If you wish to find out more about choosing your optional modules, please attend the presentation of options meeting in week 1.
- Have you registered for your optional core modules by Monday 16 October?
- Have you registered on Tabula for all your Term 1 Support and Feedback classes?
- Have you checked your date/time/day of your next lectures and Support and Feedback classes on Tabula?
- Do you know about <u>Advice and Feedback</u> <u>hours</u> to ask questions about your modules?
- Are you familiar with the <u>academic week</u> numbering system?

Your Student Experience

- Do you know who your Personal Tutor is and have you made a first appointment?
- Do you know about our <u>Wellbeing Drop-in Sessions</u> and our <u>Mitigating Circumstances</u> process?
- Have you familiarised yourself with the study spaces available in department for MSc students.
- Have you familiarised yourself with important sections of the <u>handbook</u>?
- Do you know what <u>academic support</u> is available?
- Have you been checking your emails regularly? This is vital as we communicate all the information you need via this method – you will receive emails from Lecturers, Tutors and the Postgraduate team and you must read all of them – it's great training for life in the workplace.
- Have you considered nominating yourself as a student representative for the Graduate Student-Staff Liaison Committee?
- Have you downloaded <u>MyWarwick</u> App on your mobile phone? We use MyWarwick alerts if we need to communicate with you urgently about important things to do with your study here
- If you are a Student Visa holder, are you aware of your responsibilities and the monitoring points you must attend?
- You can arrange to <u>meet with an adviser</u> from the Student Experience: Immigration and Compliance team to discuss visa issues.
