The Effects of Co-worker Absence on Labour Market Outcomes: Evidence from Brazil

Abstract: I estimate the effects of an increase in the amount of time a co-worker remains absent from the workplace on the labour market outcomes of workers who stayed at work. Leveraging a policy that allowed firms to offer two additional months of government-funded maternity leave in Brazil, I analyse how extending the length of leave in almost 55,000 workplaces affected workers and firms over time. I find significant positive effects of a co-worker's absence on wages, retention, and promotion probabilities. Consistent with models of workplace tournaments, I find considerable heterogeneity in effects across workplaces. My results also show heterogeneity in career trajectories of male and female workers, with the policy leading to a significant shift in workplace composition among high-skill positions in the workplace. These findings suggest that co-worker absenteeism, driven by the take-up of extended maternity leave, can positively influence the labour market trajectories of remaining employees, with significant implications for workplace dynamics and policy design.
