1. NDA Developments

Dr Andrew Clark, EPSRC, has asked to meet members of our I~Work team. He is the Senior Sector Manager for Healthcare, as well as the Associate Programme Manager for Medical Engineering and Ageing Research. He has approached the 9 NDA preparatory networks whose interests fall within the EPSRC's remit.

Post-meeting: Kerry has invited him to a one-hour session at the start of our next meeting on July 19. He's interested in our research interests and our views on themes for future funding streams. Joy Todd, his counterpart at the ESRC, has also been invited to this session.

Action: all members to prepare for roundtable discussion

2. Our integrated framework

We discussed and revised the objectives, tasks & deliverables of Work Packages 1-3 and 8-10 in the first draft of the I~Work Integrated Proposal, Document 13-1.

Further work is needed before we can tackle the core Work Packages 4-7. Pivotal to this exercise is a refinement of Work Package 4, the Business Case, and we agreed that a set of scenarios would be helpful. These are to cover a range of:

• tasks & work environments/systems

Each scenario should pose the question 'what if....a person's capacities changed ...OR the demands of the job changed...'. These scenarios should be brief – no more than a few sentences each. An example:

Ken Dodd is a Software Programmer who works for a mid-sized IT consultancy firm. Much of his working week is based at the client's site. He is in his 50s when diagnosed with spinal cancer and the operation leaves him paralysed from the waist down. Which tasks can he still perform? What aspects of the working environment (office, furniture, team support, equipment etc) can be adapted to his needs? What is the business case for these adaptations? Is there a broader business case for retaining his services?

Action: Each academic team is to produce three hypothetical scenarios and dispatch to Kerry by Monday June 11.

4. 2nd Draft of the Collaborative Research Proposal

Work will start immediately on the 2nd draft of the proposal, building on discussions at the Friends House meeting.

An outstanding area of work, which each partner needs to provide ASAP is:

- Previous research track record: listing prior achievements
- Past and current work in subject areas
- Academic & non-academic partners: contributions to the field & UK competitiveness
- Up-to-date CVs

Action: Kerry to devise a template for this information on Research Track Record and will distribute to partners by June 6. All partners to complete and dispatch to Kerry by Friday June 22, 2007.

Other points:

We need a glossary of terms to clarify what we mean by, for instance, work environments, work systems & work tasks.

We need letters of support from organisations, but must retain a flexible approach to the final choice of case study sites.

We should ensure that certain Work Packages appeal to specific Research Councils.
