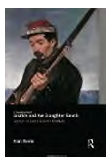

This follows Alan Norrie's successful lecture course on Critical Approaches to Criminal Law held in March 2016 at NLUD.

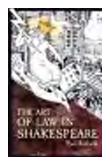

CENTRE FOR OPERATIONAL RESEARCH  
IN POLICING (COPR)

We continue to engage with cutting edge interdisciplinary research designed to inform policing policy and practice. Professor Jackie Hodgson in the Law School co-directs the Centre with Professor Neil Stewart (Psychology) and they are working with Dr Kevin Hearty (Law) and Dr Kim Wade (Psychology) on an ESRC funded project evaluating of the impact of SmartWater technology and other interventions, on public confidence and victim satisfaction with the police. Other COPR projects include, a study of public confidence in policing, research on responses to cybercrime and a behavioural science study on what makes the 'perfect cop'. Research partners include West Midlands Police, The Met and West Mercia & Warwickshire Police, while COPR researchers have also been actively involved in training members of Greater Manchester police. COPR also benefits from having a number of PhD students undertaking original research projects on areas like stop and search and the disclosure of evidence during interrogation.

## CRIMINAL JUSTICE CENTRE (CJC)

We've had a busy first term with [many events](#), including two inspiring public lectures by Eric Allison and Jo Berry. Eric, the Guardian's prison correspondent, gave a talk on the punishment of children, partly drawing on his own experience; and Jo, the founder of Building Bridges for Peace, spoke about how she came to know and work with Patrick Magee, the man responsible for the death of her father in an IRA bombing in the Grand Hotel in Brighton in 1984. We also celebrated the [publication of two books](#) by CJC members: *Justice and the Slaughter Bench* by Alan Norrie; and *Access to Justice and Legal Aid* by Jackie Hodgson and Asher Flynn.

The last year has seen the award of PhDs to four CJC researchers: Yu Mou, Bayan Alshabani, Laurène Soubise and Juliet Horne. Bayan now works as assistant professor and legal affairs coordinator at Effat University in Saudi Arabia, and Yu as a lecturer at Hull University. Both Laurène and Juliet continue to teach at Warwick.

## MODULE SPOTLIGHT



### Art of Advocacy - Mooting Shakespeare-Style

Student mooting at Warwick Law School has a proud pedigree. Indeed, two Warwick alumni – Keven Calder and Shameer Sacranie – founded one of the first mooting websites way back in 1997. Almost twenty years later, the law school has now introduced its first module devoted to improving students' advocacy skills.

*The Art of Advocacy* was introduced in 2016 by Professor Gary Watt, who is a National Teaching Fellow and in 2009 was named UK Law Teacher of the Year. Professor Watt is the co-author with his Warwick Law School colleague Dr John Snape of *A Student Guide to Mooting* (Oxford), but the distinctive quality of the new module is its emphasis on the artistic or rhetorical dimension of advocacy. Students learn how to speak well in a legal context with reference to examples from politics ("Brexit" and the US Presidential campaigns have provided timely examples), but also with reference to such classical authorities as Cicero, Quintilian and Aristotle (here the recent book *The Art of Persuasion* by Adrian Whitfield QC has been very helpful) and most of all with reference to arts developed in the theatrical context.

Professor Watt regularly leads workshops in rhetoric at the Royal Shakespeare Company and in that context the emphasis is upon the combined persuasive effect of word, movement, gesture, costume, staging and props. The first group of students reports that these insights have been useful in producing better mooters and, more importantly, people who are better prepared to present themselves in all walks of life.
