Dear Student

A short briefing today as the examination season draws to a close. For those lucky enough to have finished, I hope you are enjoying the summer. To those approaching their final examination – the very best of luck. Please read the briefing, it includes important information on the MC process, the release of results and your Graduation, and for first year and intermediate students, what to do if you are late in your Module choices.

1. Mitigating Circumstances

You can submit mitigating circumstances at any point up to June 13th for finalists, and June 20th for everyone else. We cannot cannot consider any further submissions after this date. If your health or personal circumstances affected your performance, please make sure you make a formal application **with evidence** before this date. Further details are <u>HERE</u>.

Mitigating circumstances deadlines:

- June 13th Finalists and All Law and Sociology Degree Students
- June 20th Everyone else

2. Examination Boards and 2024 Results

Your results and degree classification are not released until after the Examination Boards. The results will be released in tranches with Finalists receiving their degree classifications first. The dates are below.

- Thursday 4 July 2024 Finalist results to be released.
- **Thursday 11 July 2024 -** First Year results to be released and emails sent to any First Year not progressing.
- **Thursday 18 July 2024** Intermediate Students results to be release and emails send to any intermediate student not progressing.

If you have to re-sit an assessment, you will be advised in a letter and the questions will be forwarded to you a few days after the results are released. The deadline for submission of re-sit assignments is 22nd August. The late Summer examination season usually runs from late August to early September, but the timetable is yet to be published but should be available by the time results are issued.

3. Law Graduation

The graduation ceremony for Law undergraduates will take place on 19th July 2024. You will be contacted directly to book spaces at the procession – look out for the email as spaces are limited and your attendance depends on booking in advance.

4. Late Module Choices

A number of students have contacted me/the PSS team to say they were late submitting their module choices. If you are in this position you should let the Undergraduate Team know. If you inform them, the will add you to the list of late submissions and will be sending out the form for you to indicate your module choices. One consequence of being late is that your selections will take place after the initial allocation is made, but it is far more likely you will get the Modules you want if you fill in this form. Let us know as quickly as possible – that is now!

5. <u>Connaught Scheme</u>

There is still time for you to apply for the Connaught Scheme – an amazing opportunity for law students interested in Global Health to study at the University of Toronto. The closing date **is 10 June 2024** and you have until August 2025 to take up the scholarship. More details <u>HERE</u>
