#### **Dear Student**

## 1. NSS SURVEY – CALLING FINALISTS

The National Student Survey is now open for all finalist students. This is a national survey commissioned by the Office for Students, and open to students at all UK Higher Education Institutes and Colleges. It is an important measure not only of how you view your time at Warwick, but also of how Warwick Law School compares to other institutions.

We take feedback seriously. We hope you have had a wonderful time at Warwick Law School and are feeling well preparing for your final assessments and the world beyond. However, if there are issues you think should change, this is the time and place to raise them. When we ask for feedback, we are not necessarily asking you to be wholly complimentary – we are asking you to be constructive and honest. Most important is that you engage, fill in the survey, let us know when we have excelled and when we have fallen short. Only 15% of law students so far have filled in the NSS survey. We have to reach well beyond 50% to be counted so I hope all finalists will take a little time to respond.

Your views on your course, campus and experience can really make a difference to how the Law School and University structure their teaching and activities. With your feedback, we can make changes to improve the experiences of students in lower years and future students. Also – there are **prizes!**

## 2. SUPERVISED PROJECTS – INTERMEDIATE YEARS (LLB/LWH degrees)


If you do not submit an adequate proposal by the deadline, you will be placed into a stream chosen by us rather than you and your supervisor may not share your research interests. So, it is really important that you read the materials on the project website, watch the videos explaining the streams you are interested in if you did not attend the sessions in person, and then speak to Laura or James if you have any queries about the process.

#### 3. MID TERM FEEDBACK

More feedback – this time on your Modules. While we develop a new system of collecting feedback, we are very reliant on the informal, intranet-based system. Please take 5 minutes or so to feedback anonymously on your Term Two modules. The deadline for giving midterm feedback is **Friday 23**<sup>rd</sup> **February 2024**. #### 4. ASSESSMENT FEEDBACK

## 5. EXAMINATION PREPARATION

The DUG will be running online live examination preparation sessions in Term 3. We will also rerun online classes in Good Academic Practice. Regardless of your year, you need to be familiar with the OSCOLA referencing system and how not to fall foul of guidance on academic misconduct. Watch your DUG briefings for further details.

# 6. EXTENSIONS REQUESTS

In the next DUG Briefing, before the end of term, we will set out the rules around extensions in some detail. We know there will always be times when you need a little extra help and support. However, extensions are not automatically granted and must be supported by evidence. Look out for this briefing and make sure you know what to do if you are unable to meet your assessment deadlines through illness or circumstance.

#### More details on extensions here:

Please not that requests for extension and mitigating circumstances are different. An extension gives you extra time to complete your assessment if your reasons are accepted. Mitigating circumstances applications details issues that might have affected your ability to submit your assessment or to achieve your full potential. These are considered by the MC Panel and then the Examination Board when you full year results are being reviewed. It could be that the reasons why you need more time to complete an assessment will also be grounds for an application for mitigating circumstances. You will need to complete two different applications if that is the case.
