Dear First Year Student

For those of you who did not attend the Introductory Session, my name is Dr Maggie O'Brien and I am Director of Undergraduate Studies (DUG) at the Law School this year. A number of you have asked question about attendance at our introductory meetings. To reiterate, attendance is compulsory and engagement is expected. We can only authorise absences for a limited period. If you cannot attend University for more than a week, please contact your Personal Tutor in the first instance to discuss. PT meetings

A number of you have asked about meetings with your Personal Tutors. You don't need to contact them – they will contact you to set up these meetings. Make sure you attend when invited as this is a really important support for you over the three or four years of your degree.
