Hi all,

A few things to draw to your attention on the PGR front.

#### 1. PGR Scholarships

A reminder that many of the PGR scholarship pathways (ESRC, AHRC etc) are now accepting applications.

Please note that this year (unlike last year) the Law School Scholarship will be open to existing students. Any award to an existing student will cover prospective years of study only; the award will not retrospectively apply to any years of study already completed. Please also note that the Chancellors International Scholarship is not any longer open to existing students, only new students can apply.

More information about the scholarships (including relevant deadlines and application processes) can be found <u>here</u>. If you'd like to discuss any of these pathways, just let me know.

#### 2. Extension requests

The Doctoral College has issued some guidance for students and supervisors who are considering applying for an extension. Please make sure you familiarise yourself with the <u>criteria for approval and process</u>.

- Students are being refused extensions, or are being given shorter periods than requested, because they do not present and evidence acceptable mitigating circumstances.
- Note that Covid (on its own) is unlikely to be a sufficient reason to approve an extension.
- Applications will be returned if there is not a statement of support from the supervisor and a plan for completion to the requested extended submission date.

## 3. Midlands Innovation Fellowship 2024

The Parliamentary Office of Science and Technology is launching two new fellowships. The fellowships are funded by Midlands Innovation and the scheme is open to PhD students studying a subject related to biology, life sciences and social sciences within certain institutions. Applicants must be registered, or have recently completed their PhD, at one of the following universities:

- Aston University
- University of Birmingham
- Cranfield University
- University of Keele
- University of Leicester

- Loughborough University
- University of Warwick

The two successful applicants will be based in UK Parliament for 13 weeks from April 2025, supporting its use of research evidence in scrutiny and decision making. This will typically involve producing a POSTnote policy briefing which will be published on the UK Parliament website. Fellows can delve into novel and exciting areas of research, develop a unique understanding of how research informs policy in the UK Parliament, and forge relationships with key stakeholders.

Hybrid, remote working, and part-time options are available.

The successful fellows will be awarded a stipend of £7,922.50 (or a stipend-matched payment for clinical PhD fellows if higher).
