About the Event

Negotiations are now underway for the creation of the UN Framework Convention on International Tax Cooperation (FCITC) after decades of advocacy for tax justice by civil society groups and developing countries. This roundtable will bring together academic, policy, and practitioner perspectives to explore the proposed landmark tax treaty and its implications for global tax reform. Our panel will provide the background to the treaty and discuss challenges ahead for negotiators, advocates and campaigners and explore the relationship between the global tax regime, human rights, social justice and sustainable development. There will be opportunities for Questions and Answers from the audience.

Professor Sol Picciotto is Emeritus Professor at Lancaster Law School and Honorary Professor at Warwick Law School He is also Senior Fellow at the [International Centre for Tax and Development](#) and a Senior Adviser of the [Tax Justice Network](#), and coordinator of the [BEPS Monitoring Group](#).

Dr. Maria Ron Balsera is a feminist researcher and Executive Director at the Centre for Economic and Social Rights (CESR) and oversees CESR's programmatic work and team.

Dr. Matti Kohonen is Director of the [Financial Transparency Coalition](#), researcher on tax and fiscal policy and a founding member of the [Tax Justice Network](#).

Dr. John Snape is Associate Professor at Warwick Law School with expertise in public finance law and policy.
