Module Selection Guidance for LLM International Corporate Governance and Financial Regulation and in International Economic Law

Choosing your Modules

From the Law School Postgraduate Welcome Pages you will have access to our <u>module taster videos</u>. Even if you have a good idea of which modules you would wish to select, we encourage you to watch as many of the relevant videos as possible before finalising your module choices. The module taster videos will give you a good sense of the overall content, teaching style and presentation of modules.

Full-Time Students

If you are a full-time student, you must select your core module (see below), <u>LA984: Dissertation</u>, <u>Research and Writing Module</u> and two optional modules in Term 1 and three optional modules in Term 2.

International Economic Law: Your core module is <u>LA908: International Economic Law</u>.

International Corporate Governance and Financial Regulation: Your core module is <u>LA9A3</u>: <u>International Corporate Governance and Financial Regulation</u>.

With the exception of LA951 Theory and Practice of International Development Law and Human Rights, it is possible for you to choose a core module of another course as an optional module provided there are spaces available. Priority will be given to the students for whom the module is compulsory.

Part-Time Students

If you are studying part-time Year 1, please select four taught modules, two in Term 1 (1 of which will be your core module if applicable) and two options in Term 2.

If you are studying part-time Year 2, Please choose your remaining optional modules and Dissertation Module. For example, if you took four modules in your first year, you will need to select two further optional modules and your dissertation module for this year.

You must take a total of 120 CATS of taught modules. Your dissertation module is worth 60 CATS.

Changing Modules

We will ask you to make your module choices for both Term 1 and Term 2 by the end of Week 0. When the module timetable for Term 2 is confirmed later in Term 1, you will have a further opportunity to request any changes to your original options for Term 2.

External Modules

- If you wish to choose modules from the LLM in International Development Law and Human Rights programme, they will be considered as 'external' modules. You would need to get permission from the module convenor and your programme director and please inform the Law School Student Services Team at: <u>postgraduate.law@warwick.ac.uk</u>. Please note that priority for spaces will be given to students registered for the LLM in International Development Law and Human Rights.
- You can consider taking up to two 20 CAT modules run by external departments in the University.
- Please also note that spaces on external modules may be limited so there is no guarantee that you would be able to get a space on a particular module. That is for the Department concerned to determine.
- If you wish to take a module with an external department you will need to first seek agreement from your programme director and permission from the external department concerned. You will need to follow their guidance to apply for a place on a particular module. Quite often there will be a paper or online form to complete. Please also keep the Law School Student Services Team informed so they can ensure that you are registered for the correct modules.
- If you are taking external modules, it is your responsibility to find out when the module/s are running and to ensure that you do not have any clashes with your Law School modules. It is not possible to alter departmental timetables.
- You are able to take up to 40 CATS of external modules. They must be at postgraduate level and each must be 20 CAT modules.

Dissertation Module: Further Guidance for Part-Time Students

Core Modules

You must take your respective core modules in your first year of study.

International Economic Law: Your core module is LA908: International Economic Law.

International Corporate Governance and Financial Regulation: Your core module is <u>LA9A3</u>: <u>International Corporate Governance and Financial Regulation</u>.

Dissertation Module

You will be formally registered for <u>LA984</u>: <u>Dissertation</u>, <u>Research and Writing Module</u> in Year 2 of your studies but you will find it very helpful to attend the taught classes in your first year as they will be helping to develop your research and essay writing skills.
