INTRODUCTION

Established in August 2019, the Warwick Interdisciplinary Research Centre for International Development addresses urgent problems of poverty, inequality and social and economic change while challenging global hierarchies of knowledge and material resources. As a university research centre, we focus on fostering interdisciplinary research collaborations between Warwick colleagues, but also between our peers and partners across the globe in other universities and relevant sectors. Our four research areas – gender; peace, conflict and justice; health; mobilities – structure our work but do not constrain it. These four areas are not stand alone, but they overlap and interact, reflecting the complexities of the contemporary world.

This year we were pleased to place a new focus on our policy-facing work and to extend our networks even further than before. Collaborating with the UK Foreign, Commonwealth and Development Office on an SDG16 Roundtable on data and evidence was a particular highlight, and we will prioritise connecting the cutting-edge research of WICID members and partners with policy and practice in the years to come. We were also thrilled to invite one of our key partners, the African Network Against Extrajudicial Killings and Enforced Disappearance (ANEKED), to deliver this year's annual lecture. Dr Lesley Stahlecker spoke to us about ANEKED's work in her talk entitled 'Grassroots Activism: Boundaries and Breakthroughs'. It was particularly important to highlight the work of our partners in this way, and to learn from them.

We would like to extend our thanks to all members of our Advisory Board, Steering Committee and Partnership Network for their continued support this year. We would also like to thank all those who attended our events, read our newsletter and blogs, listened to our Think Development Out Loud Series and shared their ideas, news, and enthusiasm. We, at WICID, are grateful! RESEARCH

WICID members are working on several projects within and between our four core research areas: gender; peace, conflict, and justice; mobilities; and health. WICID supports our colleagues by collaborating on events, sharing communications, and more. In the interest of brevity, we have listed some highlights below.

PEACE, CONFLICT, AND JUSTICE

L'homme n'est pas le maître de la terre, mais la terre est le maître de l'homme: Encouters, Dialogues and Solutions for Natural Resource Management and Sustainable Development in Côte d'Ivoire

This project is a two-year (2022-2024) collaboration between British and Ivoirian academics and local communities in Côte d'Ivoire. It brings together different actors to reflect, discuss, and imagine creative outcomes and solutions for national resource management challenges. The project will also generate important knowledge about how local expertise can be incorporated into policy decision-making and what happens in the encounter between local voices, international goals, and national regulations.

MOBILITIES

Empowering Data Literacies in Displacement

How can internally displaced persons (IDPs) be empowered in contexts whereby humanitarian assistance is driven by data? The project undertakes timely and vital impact work by Data and Displacement, a recently completed AHRC-FCDO-funded project examining the ethical and operational impacts of data-driven humanitarianism in northeastern Nigeria and South Sudan. The project will co-produce a free online training package that is designed for and by humanitarian practitioners, and that is validated by — and created with — IDPs. Critical to the success of this project is: (1) an in-person workshop with selected practitioners in Geneva to discuss the content and presentation of the training package; and (2) an in-person workshop with IDP representatives in Abuja to validate and co-produce digital training materials. Costs are required for travel/subsistence and for the digital production, translation and research assistant costs. This project represents a unique collaboration with the United Nations migration agency, IOM.

HEALTH

There is no app for that! Regulating the migration of digital health data in Sub Saharan Africa

With the dramatic increase in the collection of health data in recent years, health apps have been promoted as offering huge advances in the health of people in the Global South, but they also pose risks to privacy and ultimately to health outcomes. The project team will evaluate the data protection regimes and engage with key stakeholders in Kenya, South Africa and Uganda, to establish the extent to which they protect their citizens' health data, especially in cross-border Health activities.

The interdisciplinary project led by Professor Sharifah Sekalala, Professor Bitange Ndemo and Professor Pamela Andanda seeks to analyse the regulation of health apps in Sub Saharan Africa in Uganda, Kenya and South Africa. Focusing on law, bioethics, entrepreneurship, epidemiology and policy makers, the project aims to bring together various stakeholders to empirically investigate how health apps are operating in practice, whether new forms of regulation are adequate in responding to potential problems, how different stakeholders perceive the regulatory framework and how we can create better regulatory frameworks.

Project Updates

- PI Professor Sekalala co-authored two peer-reviewed publications based on the project: 'Colonialism in the new digital health agenda'; 'Health data justice: building new norms for health data governance'.
- A workshop took place in November 2023, tackling human rights concerns in digital health, data migration, healthcare access, and equity. The event attracted a diverse audience of lawyers, activists, policymakers, students, and academics eager to engage on these critical issues.
- The project team held the Digital Health Workshop in September 2023 presentations can be viewed here. PI Professor Sekalala also gave a lecture on Law, Regulation and Health as part of the Workshop.

Encountering disability through contemporary dance in Africa

This is a network project whose key objectives are the development of sustainable working relationships between researchers, practitioners, communities engaged with disability across borders and sectors, and the creation of new mechanisms for knowledge exchange on the subject of dance and disability. The network members will meet (via Zoom) every two months to focus on: Sharing knowledge, experience and best practice (via readings or shared work with companies and organizations vested in disability dance work); Identifying issues and challenges faced by disabled people in various socio-cultural contexts and discussing ways to address them; Sharing opportunities such as calls for funding, applications for festivals, artistic residencies, etc., as well as exploring new possibilities for collaboration.

- The project investigators spoke with choreographers Nadine McKenzie (Sout Africa), Adriaan Luteijn (Netherlands) and Joseph Tebandeka (Uganda) at the BODY MOVES Festival in November 2023.
- The team organised Access Festival as part of JOMBA! In August 2024, a festival that included three days of performances, workshops, talk-backs, interviews with artists from South Africa, Uganda, and the Netherlands.

OTHER THEMES

Widening Access to Higher Education in India (WAHEI)

Widening Access to Higher Education in India (WAHEI) a 4-year research project (2022-26) that draws on and furthers the reach and impact of the first Fair Chance Foundation (FCF) project 'A Fair Chance for Education: Gendered Pathways to Educational Success in Haryana' (2017-21). WAHEI takes a key finding from the first project which is the under-utilised potential of faculty members in rural and semi-urban Higher Education (HE) institutions to have a positive effect on young peoples' HE participation and life chances. The study is based on case studies of HEIs which include state universities and affiliated undergraduate colleges across six states from different regions in India.

ADVOCACY, IMPACT AND PARTNERSHIP

During this academic year, WICID has strengthened its advocacy, impact and partnerships through broader engagements with initiatives/activities on development both within and outside of the University of Warwick. Below are some of the highlights.

WICID Joins United Nations Academic Impact (UNAI)

As part of a larger University of Warwick bid, the WICID team were instrumental in securing membership of the <u>UNAI</u>, which describes itself as "an initiative that engages institutions of higher education with the United Nations in supporting and contributing to the realization of the Organization's purposes and principles, including the promotion and protection of human rights, access to education, sustainability and conflict resolution".

New Partnership with SIDS

This year, WICID welcomed <u>Somali Institute of Development Studies (SIDS)</u> as our partner institution. SIDS is a development and resilience-focused think tank which provides high-quality capacity development, research, policy briefs and publications, and graduate programs. The institute is committed to contributing to Somalia's economic development and political stability through innovation, research and capacity development. Key study areas include development and poverty, resilience, markets, health and nutrition, environment and disaster risk reduction, peacebuilding, conflict resolution and mediation using indigenous methods, stabilization and durable solutions. SIDS believes that development is the sum of the contributions from different groups and institutions. Therefore, SIDS established partnerships with the Federal and State line ministries, academic institutions, CBOs and other I/NGOs.

Policy work

WICID co-organised and hosted a roundtable on SDG 16: Evidence Gaps, Data Access and Monitoring with the UK Foreign, Commonwealth and Development Office (FCDO). The roundtable was designed to enable a discussion between individuals from academia, FCDO and different institutions. The objective for this roundtable was to share experience, deepen understanding and identify areas of common challenge across SDG 16 with specific reference to data. The roundtable discussion focused on (1) the current challenges in data collection, access and evidence gaps, for example thematic challenges, data methodology in FCAS and effectiveness of existing data frameworks; and (2) wider SDG 16 challenges including the importance of national ownership of SDG 16, in addition to discussing government accountability and the role of donors.

WICID co-produced and co-signed, along with key academics and policymakers, the concept note, 'Who Cares in Peace building? Building Sustainable Peace and Advancing Gender Equality through Support for Peace builders with Caring Responsibilities'. This note has been circulated amongst the policy community, leading to new engagements with the UN

Research Institute for Social Development. It builds on work led by WICID collaborator, Dr Eleanor Gordon of Monash University.

- Briony Jones (Director) attended the Development Studies Association Heads of Centres meeting in November 2023.
- Shahnaz Akhtar (Executive Management) attended 'Celebration of the Coventry UNESCO
 Associated Schools Network'. This event hosted by Preet Gill MP celebrated the work
 done by schools on the Hidden Heroes project supporting UNESCO Associated Schools
 Network, connects more than 12,000 schools in 182 countries with a common goal of
 strengthening three distinct pillars education for sustainable development, global
 citizenship education and inter-cultural and heritage learning.
- Vicky Squire (Steering Committee) participated in the IOM Roundtable discussion on Charting the way forward for route-based migration research in June 2024.
- <u>African Women Playwrights Network (AWPN)</u>, of which Yvette Hutchison (Steering Committee) was a PI, was set up in Nigeria, Kenya, Botswana, SA, Zimbabwe and Diasporas (UK).
- Oyinlola Oyebode (Advisory Board) joined the Advisory Group for the National University Centre for Women and Children at National University Hospital, Singapore and Advisory Board of Newham Centre for Health and Care Equity.
- Shirin Rai (Advisory Board) gave a <u>keynote speech</u> titled 'Social Reproduction, Depletion and/in Crisis' at the Development Studies Association (DSA) 2024 conference, building on her book *Depletion: the Human Costs of Caring*.
- Briony Jones (Director) has continued collaborations with ANEKED on an open access Transitional Justice Teaching Tool which was developed further at workshops at the University of Warwick and Geneva Academy.
- In 2023, Emily Henderson, along with James Burford, both in Education Studies, founded a new Category 2 Substantive University Research Centre called the Doctoral Education and Academia Research Centre (DEAR)

Highlights from our Partners

 <u>SIDS</u> has launched the Green Media Initiative (GMI). GMI is Somalia's first green media hub, committed to promoting environmental awareness and sustainability. The work includes producing documentaries, messages, podcasts, and radio programs focusing on the green sectors and the climate impact.

- ANEKED participated in the victims' reparations bill consultative process. Working
 together with the Ministry of Justice, representatives of the National Human Rights
 Commission, the American Bar Association, and stakeholders from other civil society
 organisations focused on transitional justice in The Gambia, ANEKED was able to provide
 its input to the bill and victim's rights. The Victims' Reparation Bill was passed into law
 on November 1, 2023 and demonstrates a significant step for victims to seek redress
 and demand accountability.
- With support from international experts, ANEKED continued its work on advancing good
 practices in forensic investigations of human rights violations in The Gambia to ensure
 the quality is aligned with international standards of accountability and justice. This was
 done in order to lay the ground for the long-awaited remains of the forcibly disappeared
 to be returned to their loved ones for a befitting burial.
- Recognising the interconnectedness of victims and CSOs fighting for truth, memory, and
 justice on the continent, ANEKED ventured out of the country to share our knowledge
 and experiences with colleagues engaged in TJ processes in countries such as Guinea
 Conakry, South Sudan, and Liberia.




Methods Lab Toolkits

The South as Game Changers: Rewriting the Rules and Redefining the Boundaries

Research and other collaborative partnerships between institutions in the Global North and the Global South have been key to furthering knowledge development and sharing knowledge on a global platform. However, partnerships have been plagued with ethical dilemmas related, but not limited to, division of labour, roles and relationships, accrued benefit and output, in addition to factors that have led to epistemic injustice. There have been significant efforts made by actors in this milieu to adopt best practices and guidelines that seek to overcome these challenges and push for more equitable partnerships.





The focus on equitable partnerships between Global North and Global South institutions has been welcome and

indeed necessary. What is overlooked is the movement toward greater South/South partnerships. The toolkit explores the ways in which partnerships among actors in the South can provide a new plain for equitable partnerships. However, partnerships among actors in the South must also seek not to replicate or entrench inequalities. The toolkit aims to provide guidelines to avoid these pitfalls by introducing a self-audit that would assist institutions in the South to establish a framework that provides an equitable organisational culture that can then be reproduced in its partnerships in order to promote holistic engagement.

WICID Annual Lecture 2024 – *Grassroots Activism: Boundaries and Breakthroughs*

The Lecture focused on ANEKED's journey showcasing growth across physical, geopolitical, and digital spheres, rooted in local activism emerging from repressive conflict zones. Championing women and marginalised voices, notably as a women-led entity, ANEKED occupies spaces in transitional justice. Venturing into unexpected arenas like universities, Lesley strives to drive discourse, from local to global, aligning with critical perspectives on global inequalities and development and its significant implications on the global South.
