1 Improve cancer detection

With your help, our Engineers and Mathematicians will develop faster ways of detecting and targeting cancer. Warwick is world-renowned for being outstanding at maths, and our advanced modelling systems will help predict the outcome of cancer treatment before it even begins. That means patients receive the most personalised and most effective treatment for them.



2 Create better treatments

With your support, our Bioscientists will keep discovering how cells in different cancers behave. Our Chemists have already discovered anti-cancer drugs which are less toxic and more effective than existing treatments. As we move towards clinical trials we are developing new 'smart' drug delivery systems to target just the cancer cells, leaving the healthy cells alone. This makes treatment more effective and reduces side-effects associated with chemotherapy.



3 Care for people right here and now

With your funding, our doctors will continue offering the best of care to their patients and find ways to help them through existing treatments. For example, we're running the UK's first clinical trial into scalp cooling which can prevent hair loss during chemotherapy. Our main motivation is to make a difference to cancer patients; the way we are structured means that anything we do can be rapidly developed to benefit our local community as well as patients across the world."

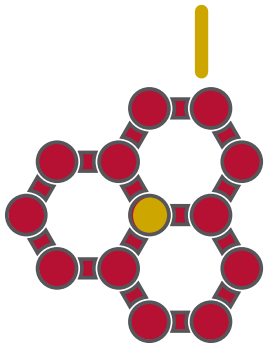

Organising your event

What inspires you most? Whether you fancy testing yourself with an extreme challenge, or want to run a tasty coffee morning, all your efforts will help our cancer researchers and raise awareness of their work.

There are five things to think about:

- 1 What**
What are you going to do? A quick search online will give you lots of ideas, from bake sales and dress-down days, to sports challenges or quiz nights. Remember, sometimes the simple ideas work best - some of us are sky-divers, others bake fab cakes - both are great for fundraising.
- 2 Where**
Where are you going to run your activity? Think through any safety issues and make sure you have a plan for them (we can help with this). Where are you going to advertise? Can your venue help? From word of mouth, noticeboards (use the poster on p.11), social media, websites and more - tell everyone what you are doing, and us too, so we can help promote it.
- 3 When**
When will your event take place? Choose a date and time that suits the people you want to reach. When are you going to start advertising? If it's a big open event, remember to let local papers and radio know (they'll especially love any photos you have). We can help with approaching the local media as well.
- 4 Who**
Who's involved in the event and who can help run it? Friends, family, local businesses. We can help with advice, letters of introduction, collecting tins, t-shirts, banners, stickers, leaflets and more - just get in touch.
- 5 Why**
Why are you doing this and how much are you trying to raise? It's helpful to tell your story so people know why you're passionate about achieving your fundraising goals.



Photos make the difference: keep them high-resolution, brightly lit, with lots of great smiling faces - remember, pictures of 2-3 people can have the most impact.

Dr James Gill

GP and Fundraiser



Dr James Gill is a GP and a part-time lecturer at Warwick Medical School. James decided to fundraise to purchase new and innovative breast examination models, to offer training to medical students and GPs in identifying potentially cancerous lumps, and to help the general public understand the early warning signs of breast cancer.

James, a keen cyclist, set up Biking 4 Breasts: a 24 hour, 2,000km bike ride using static bikes and a relay of riders. He got support from local bike shops who gave bikes, promotion and prizes for the event, and promoted it on the radio and in the local press.

The day was a huge success, and his team raised enough money to buy five sets of breast models. These are now being used to improve early breast cancer detection in Coventry and Warwickshire.
