RESOLVED:

RESOLVED:

- (a) That the report from the Chair on strategic overview of enhancement activities and mechanisms for disseminating good practice be welcomed;
- (b) That the report form the basis of a searchable database of teaching and learning enhancement projects and interests, available through the University website and possibly hosted on the Teaching Grid website, using links to existing information and consistent tags or other meta-data as appropriate, noting the benefit of ease of updating and expanding afforded by dynamic webpages;
- (c) That consideration be given to appropriate methods of showcasing teaching and learning enhancement projects to external visitors to the University website, including potential students, as well as to current students:
- (d) That the report be circulated to members of the Group to enable easy onward transmission to other colleagues.

26/07-08 QAA Institutional Audit (minute 20/07-08 referred)

CONSIDERED:

27/07-08 Teaching Grid

CONSIDERED:

An oral report from the Teaching Grid Manager, Rachel Davis, on plans for the opening, ongoing work and evaluation of the new Teaching Grid, noting:

- (a) the Teaching Grid would open on 3 March, with the e-Learning Showcase Day taking place on 10 March and departmental inductions extending over a number of weeks;
- (b) the different flexible spaces in the Teaching Grid, including the experimental teaching space, the consultation area and the social discussion area, and the range of furniture, equipment and resources available for use;
- (c) initial staffing levels and the ethos of support in the Teaching Grid, including the creation of communities of practice, links between academic and teaching staff in different departments and faculties, and referrals on to central service departments and agencies which are in a position to assist with teaching and learning development;
- (d) that ongoing evaluation through a range of mechanisms will inform the evolution of the Teaching Grid as a space and a service, with a Working Group established to meet quarterly and review progress.

RESOLVED:

That plans for the opening, ongoing work and evaluation of the new Teaching Grid be welcomed, and that the following points be noted in its operations and evolution:

- (e) That the tension between whole-Grid bookings and drop-in availability would need to be managed carefully;
- (f) That the Teaching Grid could be an appropriate space to host events for Faculty enhancement groups;
- (g) That the Teaching Grid could be an appropriate space to host events involving or organised by external visitors, including colleagues from the Higher Education Academy and the subject centres;

28/07-08 Warwick Awards for Teaching Excellence
