### Apply inside the UK

extend your Student visa

You can apply to extend your Student Visa from inside the UK if the following applies: you hold a current, valid Student Visa, AND

- You have an unconditional offer with a CAS for a new course of study taught at a higher level than your previous UK study, AND
- The start date of the new course is no later than 28 days after the expiry date of your current Student Visa

### OR

 You're a current Warwick Student who needs additional time to continue a PhD, to resubmit a thesis, or who has added a year to an Undergraduate course of study • switch to a Student visa from another type of visa

You may be eligible to apply to switch into the Student Visa route from inside the UK if you already have permission to be in the UK. If you are unsure, please contact the Student Visa Advice Service.

You cannot switch if you hold any of the following types of leave: Visit Visa, Short-term Study Visa, Parent of a Child Student Visa, Seasonal Worker Visa, Leave outside the Immigration Rules.



Ensure you have a secure internet connection and allow at least 30 minutes to complete the application form.

Most CAS assigned by Warwick for courses taught at degree level or above will confirm that the institution has made its own assessment of your English language ability. This might apply to you if the course you will study at Warwick is below degree level.



ATAS clearance is subject to nationality, course level and area of study – not everyone requires it.

If your visa application is for a new course of study which requires ATAS, you will have been asked for a valid ATAS certificate as part of your offer conditions, and this will be confirmed on your CAS.

If you are applying to extend an existing visa to continue the same course of study, and your previous CAS confirmed the course was subject to ATAS, then you'll need a new ATAS certificate before you can submit your extension visa application.

If you are switching to a Student Visa from another category and ATAS was an offer condition, you'll need a new ATAS certificate before you can submit your extension visa application.

If you answer *YES*, you'll then be asked for your ATAS reference (not shown).

If you do not require ATAS clearance, answer NO.
