

Independent students who are Care Leavers

The information on this page is for young people who are thinking of applying to Warwick as an Undergraduate student for 2024 entry and are [independent because they are leaving care](#). If you are planning to apply elsewhere, we would encourage you to contact your university choices to see what support is available to you.

1. 'Care Leaver' definition

If you are a 'Care Leaver', this means that you were in the care of your local authority for at least 13 weeks at any time since the age of 14 and were in care on your 16th birthday. This care may have been provided in many different settings, including:

- Living with foster carers
- Living in a residential children's home
- Being looked after at home under a supervision order
- Living with relatives under a guardianship agreement

If you are under 19, have left care and have been living independently, we can also offer you additional support. Or, if you have never been in the care of your local authority, but are not in contact with both of your parents (known as 'estranged'), please go to our [Independent students who are estranged](#) webpage for further advice and guidance.

2. Applying to University

Students apply to university through the UCAS application form. This form includes your personal details, personal circumstances (this is where you can tell your university choices that you are/have been in care), educational history, predicted grades (where applicable), your course choices, your personal statement and your reference.

We would encourage you to tick the 'care experienced' tick-box on the UCAS form so that your university choices are notified of your circumstances and can offer you appropriate support, information and guidance. You can find out more about this tick-box online [here](#).

Evidence

The universities you apply to may ask you to provide evidence of your care leaver status so that appropriate support can be arranged for you. At Warwick, we advise students to provide evidence such as:

- A signed letter or email from your school, social worker or personal advisor confirming you are a care leaver.
- Evidence that you have been in receipt of Income Support and Housing Benefit during your post-16 education.

3. Applying for Student Finance

You can apply to Student Finance England (or the equivalent awarding body in Wales, Scotland or Northern Ireland) for financial support with your tuition fees and living costs.

Tuition Fee Loans: These loans are paid directly to your university.

Maintenance Loans: These loans are usually means-tested (based on household income) and are paid to you.

To apply for financial support as a Care Leaver, you will need to complete an online application form and apply as an '**Independent Student**'. Your local authority (usually a Personal Adviser or Social Worker) will need to provide a letter to support your application. Should Student Finance approve your application, your 'household income' will usually be assessed as £0 and you will usually be awarded the maximum maintenance loan for the duration of your undergraduate course.

here. Please note that the supporting letter from your local authority must confirm:

1. That you were looked after by a local authority (this includes being placed in foster care by your local authority)
2. The dates that you were in care
3. That you have not returned to the care of your parent(s) prior to the first day of the first academic year of your course

4. Support from Warwick for Care Leavers

Students who are independent because they are Care Leavers are able to access a wide range of support from Warwick. ***Please note that some of this support is provisional on providing evidence of your care leaver status (see 'Evidence' in section 2 above):***

Undergraduate Study	<ul style="list-style-type: none"> • Financial support: A Warwick Bursary of up to £3,000 per year, a Widening Participation Bursary of £1,000 per year for Independent Students who are Care Leavers and a Warwick Scholars Bursary of up to £2,000 per year. • Accommodation: Eligibility for 52-week on-campus accommodation for the duration of your studies (if desired). This accommodation package includes a 40/44-week campus room plus summer accommodation over the vacation and September period. <ul style="list-style-type: none"> ○ Please note that students are required to move rooms as part of the University's 52-week campus accommodation package. You can find out more about this, and more information about 52-week accommodation costs, in our 52-Week Campus Accommodation FAQs. • Warwick Scholars: Eligibility for the Warwick Scholars Undergraduate Programme. This programme provides students with access to bespoke activities, along with academic, personal and professional development opportunities. • WP Lifecycle Team: Additional support from the WP Lifecycle Team. We offer 1-1 check-ins and signposting support, for example, while you're on course.
Postgraduate Study	<ul style="list-style-type: none"> • Warwick Taught Masters Scholarship (WTMSS): Priority eligibility for the WTMSS scholarship scheme.
Care Leavers also have access to a range of support services open to all students across the University, including:	

- A **Personal Tutor** who you can reach out to for additional support while you study at Warwick (we would encourage you to share information about your circumstances with your Personal Tutor so that appropriate support can be offered during your studies)
- **Wellbeing Support**
- **Disability Services**
- Accommodation Support from the **Residential Community Team**
- **Student Advice Centre**
